Additional sanctions or community service hours may be assigned by the civil citation coordinator. You have the right to refuse this citation or discontinue the civil citation program at any time and have your case referred to the office of the state attorney, second judicial circuit. Ineligible Offenses for Juvenile Civil Citation

- Non-Wildlife or Fisheries Related Firearms / Weapons Offenses
- Traffic-Related Offenses
- All Felony Offenses
- Persons identified as gang member under §847, F.S.
- Refer To Your Agency Policy for Additional Ineligible Offenses.

Procedures For Issuing a Juvenile Civil Citation

To determine eligibility, call the Civil Citation Coordinator at DISC Village, (850) 575-4025 (8a-5p) or Juvenile Assessment Center (850) 575-2851 (24/7).

Explain the options to them and the importance of calling before the <u>seven-day deadline</u>.

Contact Parent/Guardian. If contact has not been made, please document it on the form under notifications.

Provide them with a copy of the citation.

Reasonable attempts must be made to contact any Victim(s) with the advisement of their rights per *Marsy's Law*. A victim does not have to agree to the Civil Citation.
