Juvenile Deflection and Pre-Arrest Diversion

A recent report indicated that results attributed to juvenile deflection programs were "astonishing" and cited programs such as the Florida Department of Juvenile Justice's Civil Citation program and the Cambridge Safety Net Program as two very successful initiatives. Important to note was a major part of their success was attributed to properly set up and maintained data systems and processes.

Another critical point was being sure to measure more than just recidivism, pointing out that other markers such as mortality rates, marriage rates and educational successes were just as important. Ms. Duncan attended the **Convening on Deflection and Pre-Arrest Diversion in North Carolina sponsored by the Wilson Center for Science and Justice at Duke Law on June 29th.** This well attended all-day event is connected to a National Governor's Association (NGA) project focusing on D/DPAD programs. It was geared towards those who are considering a program and for those who have started a program and highlighted initiatives throughout NC. There are several LEAD programs in NC!







Ms. Duncan attended the NCHATS (National Center for Health and Justice Integration for Suicide Prevention) In-Person meeting in Detroit this past April. As well as being part of the group discussion, she also participated as a member of an expert panel. NCHATS was established by Michigan State University, Henry Ford Health, and Brown University because about one death by suicide reported every 11 minutes in the United States and an increased risk of suicide in individuals involved in the justice system is a serious matter that must be addressed.
