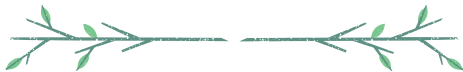

The Civil Citation Diversion & Deflection Network has 3 directory maps- national, international and the State of Florida, with juvenile and adult listings.

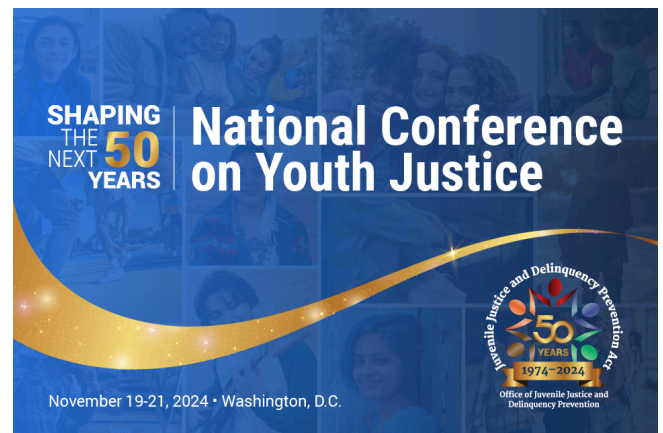
